Gift Aid is reclaimed by the charity from the tax you pay for the current tax year. Your address is needed to identify you as a current UK taxpayer.

In order to Gift Aid your donation you must tick the box below:

What is Gift Aid?

Gift Aid is the scheme under which you make a donation on which a registered charity can claim back the income or capital gains tax you have already paid or will pay by the end of the tax year. For example, a gift of £80 is worth £100 to Grace Church - that's the £100 you earned before you paid 20% tax on it!

How do I give via Gift Aid?

Just make a donation by any means. Sign the Declaration opposite, or let us know you want to gift aid so our Gift Aid Administrator can contact you. We suggest you make **one** declaration covering **every donation you might make to Grace Church from now on**. You wouldn't have to sign any more forms after that if you donated again at any time, though there is **NO** commitment to make more than one donation. You can cancel the declaration at any time, too. **You can now also make a declaration on our website Giving page.**

Points to watch

Gifts can only be from **one named individual** .

If you use a cheque from a **Building Society account** please make sure your name is mentioned on it - if not, write it on the back. If you give via **telephone or internet banking**, please quote your name as the reference. This is so we can provide an audit trail to HM Revenue & Customs.

If you want to make a **cash donation**, please **put it in an envelope** with your name on it. Please fill in the form opposite and place it in the envelope with your donation. If you make subsequent cash donations just put your name on the envelope.

I want an easy way to give regularly

Just pay by standing order. There's a standing order form on the back of this leaflet. Alternatively, set one up via telephone or internet banking using the account details on the form. See our website for online payment help.

Does it matter if I pay tax only at lower rate?

No. You just need to be sure that you will have paid enough tax in the current tax year to cover what we and any other charities you gift aid to will claim back. See opposite for full details.

How do I know what tax you'll claim back?

Take the amount of your gift and multiply it by 1/4.

What if I pay higher rate tax?

People who pay tax at the higher rate can also get relief on income or capital gains tax on their donations You can claim this via your taxreturn.

Can I cancel a declaration?

Yes, at any time. There is no forward commitment.
